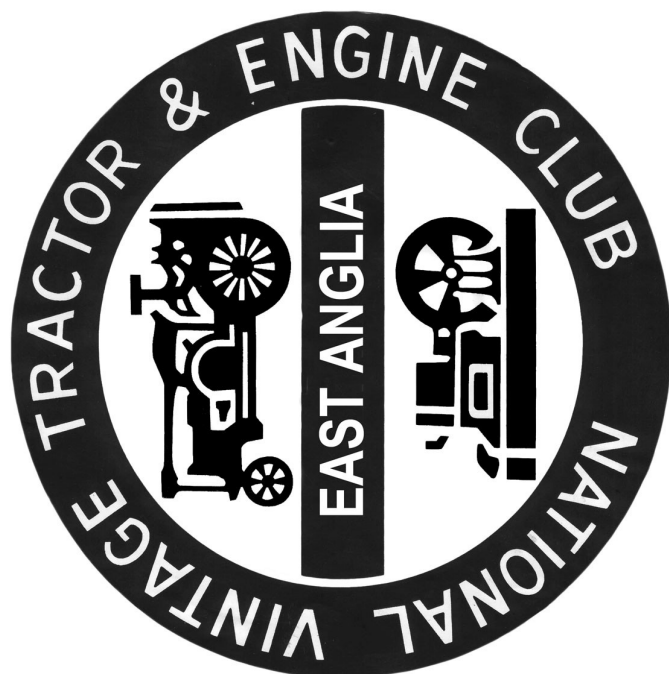

## Members Insurance Scheme 2026

### General comments.

- **Public liability Insurance** is included in the membership fee.
- **Children under 13** can **not be insured** under this scheme

### Public Liability

Some key points are:

- Our scheme provides public liability cover for exhibitors at a rally or working event.
- Public liability insurance covers all stationary and hot air engines and static agricultural items not attached to a tractor (e.g. plough, harrow, sawbench etc) and any table top or awning display, agricultural or non agricultural. It also covers any walk behind powered machine (e.g. Allen Sythe, BMB Plowmate etc). It does not cover any ride on machine or steam engine.
- Self propelled vehicles require road traffic act cover. You will need to arrange this separately.

### Road Traffic Act

The law requires that all self propelled equipment on a rally field or working event have insurance that meets Road Traffic Act requirements. This means:

- **Our members public liability** scheme does **not include road traffic** act cover.
- All drivers must be **16 or over**
- It is **your** responsibility to ensure the cover you take out **meets your needs**.
- The club is not in a position to offer RTA insurance. At the time of writing this the best advice we can provide is:
  - The NFU are offering discounts to members
  - We hear reports of good deals from specialist vintage insurers so it may pay to shop around.

## Membership Renewal 2026

Please take time to read these notes.  
It will save time and ensure you get what you require.

### Section 1

- All mail will be sent to the first named person.
- All people requiring public liability insurance must be clearly named
  - **Full or junior** - one person insured
  - **Joint** - two adults insured - living at the same address
  - **Family** - two adults insured and up to 3 children (not insured) under the age of 13 years old.
  - No insurance for under 13's

### Section 2

- Please complete your contact details as fully as and accurately as possible. We **must** have your **postcode** or your **Vaporising** will **not be delivered**.
- Sign and date the form

### Section 3

- Decide which membership type you require and tick the appropriate box.
- Enclose the appropriate fee. BACS is our preferred payment method. We also accept cheques or cash.

# National Vintage Tractor & Engine Club East Anglia Group

The National Vintage Tractor & Engine Club has been in existence for over 50 years and has members all over the country.

The National organisation is split up into local groups of which East Anglia is part.

NVTEC publishes a magazine. "Vaporising " which provides information on many levels, it also has a Safety Code recognised by many rally insurance companies. Each year the East Anglia Group runs a Rally held on the 1st bank holiday in May, located at Stradsett Park near Downham Market, Norfolk, we also run a charity Tractor Road Run in April and a Working Weekend in late August or early September. We are also able to join other groups at their rallies.

Winter meetings are held on the 3rd Thursday of the month from October – March at Ryston Golf Club near Downham Market, there are also summer visits to join in. The club also supports other shows with our club stand and all members are welcome.

We as a group publish a quarterly magazine "Vintage Torque". It supplies group news, meeting topics, rally dates, contact information and calendar information. Vaporising the National magazine will also have many topics and calendar information for you to read and join in with.

An integral part of the NVTEC membership is Public Liability Rally Insurance covered by NFU Mutual. This provides [you Personally with Public Liability Insurance](#) for the Rally field activities with a limit of £10,000,000 per incident.

### It Does Not Provide

- **Any form of Property Insurance**

Or

- **Road Traffic Act Cover** — The law requires that all **self propelled / ride on equipment** on a Rally field or working event has insurance cover that meets Road Traffic Act requirements. You should make separate arrangements if you require this.
